Agenda Items for the Performance Review Committee (PRC)
Meeting of the States and UTs on National Social Assistance Programme
(NSAP)
to be held on 13th May 2008

1. Identification of the additional number of beneficiaries

All States were requested on 17th October 2007 to identify additional number of beneficiaries to be covered under Indira Gandhi National Old Age Pension Scheme (IGNOAPS) which was formally launched on 19th November 2007 at the hands of Hon'ble Prime Minister. Old Age Pension were earlier provided under National Old Age Pension Scheme to persons who were 65 years or higher and 'destitute'. As per the modified eligibility criteria old age pension under IGNOAPS is now to be granted to person who is 65 years or higher and belonging to a household below the poverty line according to the criteria prescribed by the Government of India. For identification of beneficiaries 'BPL List 2002' prepared on the basis of 13 parameters is to be utilized in rural areas and in urban areas such a comparable list has to be used. Information has been received from 32 States/ UTs and still awaited from 3 States.

The numbers of additional beneficiaries furnished by the 23 States / UTs have been found to be acceptable. These are Andhra Pradesh, Chhattisgarh, Goa, Haryana, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Karnataka, Madhya Pradesh, Rajasthan, Tamilnadu, Uttar Pradesh, West Bengal, Arunachal Pradesh, Mizoram, Sikkim, Tripura, A & N islands, UT of Chandigarh NCT Delhi, Dadra and Nagar Haveli and Lakshadweep. The additional numbers have been accepted keeping in view (i) the number of beneficiaries covered during 2006-07, (ii) estimated number of beneficiaries based on the projected population of the State as on 1.3.2006 and 2004-05 poverty ratio of the State and (iii) estimated number of beneficiaries based on the permissible numbers of BPL families for inclusion in 'BPL List 2002'. The detail of these numbers can be seen at Annexure-I at Column 6, Column 9 and Column 5 respectively.

Punjab, Manipur, Nagaland and Puducherry have furnished higher numbers and they have been requested to cross check and rationalise the additional number of beneficiaries. Bihar has been asked to confirm whether identification has been made from the 'BPL List 2002'. Mizoram has requested for covering still further number of additional beneficiaries and they have also been requested to cross-verify the same. The State of Orissa has requested to allow them to use BPL List 1997 instead of 'BPL List 2002' as the finalisation of 'BPL List 2002' may take time.

Since then Punjab and Nagaland have furnished the clarification. Information has also been received from Maharashtra, Kerala, Punjab, Meghalaya and Nagaland. These are being examined.

States of Assam, Gujarat and Utrakhand have not yet furnished information on additional number of beneficiaries.

All States may note that in view of the modified eligibility, all new sanctions for old age pension since November 2007 are expected to be based on 'BPL List 2002' only.

2. Certificate regarding universal coverage

As per the Government of India's decision, the States are required to furnish a certificate that all eligible beneficiaries have been covered under IGNOAPS. It is expected that such a certificate will be furnished by 30th June 2008. No additional numbers for coverage of old age pension will be expected after that date except for those who cross the age of 65 years and thus become eligible for the old age pension.

3. Disbursement of pension

As per the decision of the Government of India, old age pension has to be credited, where feasible, in a Nationalised Bank or Post office Saving Account of the beneficiary. At present various methods are being adopted by the States for disbursement of pension. The frequency of disbursement is also not uniform. The mode and the frequency of disbursement of pension followed by the States/UTs is given at Annexure-II.

States are requested to furnish a certificate to the effect that pension is being disbursed through Nationalised Bank or Post Office Saving Account where feasible. It is expected that such a certificate will be furnished by 30th June 2008.

4. Physical and Financial Progress during 2007-08

- (i) All States have been requested to furnish the monthly progress report in the proforma prescribed. However, only a few States are sending monthly reports whereas others are still sending the report quarterly. All States have furnished the report of December 2007. However, only the States of Bihar and Meghalaya furnished information for the months of January 2008 and February 2008. No State has furnished information for the month of March 2008.
- (ii) The Physical and Financial progress of different States during 2007-08 is given at Annexure III.
- (iii) Releases of 2007-08 were made based on coverage of beneficiaries including the new beneficiaries identified under IGNOAPS and after providing opening balance for at least two months.

5. Allocation and releases of 2008-09

The BE for 2008-09 under NSAP is Rs.3500 crore out of which Rs. 3000 crore were distributed among different States/UTs based on the requirement for 2008-09. The number of beneficiaries reported by the States and the opening balances were taken into account for arriving at the requirement during 2008-09. The final allocation will be made after augmentation of funds at the RE stage. The amount for the first two months has been released by the Ministry of Finance. Details of releases are at Annexure-IV.

6. Coverage under National Family Benefit Scheme (NFBS)

Under NFBS Rs. 10,000 is given to a BPL family on the death a primary bread winner between the age of 18-64 years of the family. Given the population figures in the age group of 18-64 years and the mortality rate and the poverty ratio, it was estimated that 4.35 lakh deaths need to be covered under NFBS in a year. However, the coverage during 2006-07 was 2.05 lakh and during 2007-08 it was 2.38 lakh. Thus, there is a large variation between the expected & the reported coverage which can be seen at Annexure-V. All the States require to step-up efforts and ensure that all deaths of primary bread winners among BPL families are covered.

7. State Fund Schemes

Several States are having their own widow pension and disability pension schemes and some of them are also granting old age pension for persons who are above the age of 60 years. Information has been ascertained on several occasions regarding State sponsored social security schemes. The information has been tabulated and placed at Annexure VI (A) to (C). The State Governments may verify the information and give updates on these schemes.

8. Computerization of details of beneficiaries of IGNOAPS

It has been decided to computerize the details of beneficiaries of IGNOAPS and devise a system to directly credit the pension amount into the bank/ post office account of the beneficiaries. For this NIC had put in place a dedicated team for development of the software. Three Regional Workshops were held to discuss and gather information about the forms, procedures and processes followed in various States for identification of beneficiaries, sanction and disbursement of pensions. NIC has documented the functionalities and process flow and the same were forwarded to 21 States for verification and confirmation so as to proceed further for preparation of SRS for the Common and Core System for the proposed IGNOAPS- MIS for the whole country.

States of Karnataka, Orissa, Tripura, Jammu& Kashmir, Rajasthan, Mizoram and Nagaland have furnished their comments. However, replies from the State of Andhra Pradesh, Bihar, Chhattisgarh, Haryana, Himachal Pradesh, Jharkhand, Karnataka, Madhya Pradesh, Punjab, Tamil Nadu, West Bengal, Assam, Meghalaya, Sikkim, and Puducherry are still awaited.
